In the event of my election, I agree to abide by the Code of Ethics of the National Association of REALTORS®, which includes the duty to arbitrate, and the Constitution, Bylaws and Rules and Regulations of the above-named Board, the State Association and the National Association, and if required, I further agree to satisfactorily complete a reasonable and non-discriminatory written examination on such Code, Constitutions, Bylaws and Rules and Regulations. I understand membership brings certain privileges and obligations that require compliance. Membership is final only upon approval by the Board of Directors and may be revoked should completion of requirements, such as orientation, not be completed within time frame established in the association's bylaws. I understand that I will be required to complete periodic Code of Ethics training as specified in the association's bylaws as a continued condition of membership.

Returning members – please note

NAR/NYSAR Local board policy: Dues should only be pro-rated for New Members or those who have been out of the business for more than a year (ie did not pay dues the previous year). Per Nar: National dues are pro-rated for new members based on the join date. This proration only applies in the calendar year the member joins. Thereafter, full year dues are due and owing by January 1st. Members who paid dues for the previous year must pay full year dues, regardless of when they re-active their membership.
