I understand membership brings certain privileges and obligations that require compliance. Membership is final only upon approval by the Board of Directors and may be revoked should completion of requirements, such as orientation, not be completed within the time established in the association's bylaws. I understand that I will have to complete periodic Code of Ethics training as specified in the association's bylaws as a continued condition of membership.

If the applicant resigns or otherwise causes membership to stop, the duty to submit to arbitration continues in effect even after membership lapses or is terminated, provided the dispute arose while the applicant was a REALTOR®.
